ELMER LUCILLE ALLEN LIFETIME ACHIEVER AWARD

Lonnie Ali, a native of Louisville, Kentucky, completed her BA degree at Vanderbilt University in Nashville in 1978. After graduation, Lonnie began her business career with Kraft Foods, Inc. She continued her studies at UCLA's Graduate School of Management and received an MBA in 1986.

After her marriage to Muhammad Ali in November 1986, she assumed responsibility and management of his business affairs. In 1992, she formally incorporated Greatest of All Time, Inc. (GOAT, Inc.) to centralize and license her husband's intellectual properties for commercial purposes. She served as Vice President and Treasurer of GOAT, Inc. until the sale of the company in 2006. During her tenure, Lonnie managed the company's daily operations and accompanied Muhammad on business trips and humanitarian initiatives. domestically and around the world. After the sale of GOAT, Lonnie was asked to serve on the management board of the newly formed Muhammad Ali Enterprises.

In 1997, Lonnie and Muhammad helped launch the Muhammad Ali Parkinson's Center (MAPC) in Phoenix. Lonnie and her husband unveiled the Muhammad and Lonnie Ali Pavilion in 2009 which houses



the Muhammad Ali Parkinson's Center at Barrow Neurological Institute.

She and her husband opened the Muhammad Ali Center in Louisville in November of 2005, where she serves as a Lifetime Director and as Vice Chair of the Center's Board.

Lonnie has been active in various charitable causes including advocating for children's rights and Parkinson's disease research. From 2010 to 2013, Lonnie served on the Presidential Commission for the Study of Bioethical Issues.

Lonnie was the 2010 recipient of AARP's Inspire Award, was named in 2012 as one of Arizona's 48 Most Intriguing Women and inducted into The National Consortium for Academics and Sports Hall of Fame in 2013. She has also been honored by The Foundation of Wesley Woods with the Key to a Cure Award, Child Help and the HollyRod Foundation. Lonnie recently received the Keep Memory Alive Caregiver Hero Award from the Cleveland Clinic's Keep Memory Alive Power of Love® gala and most recently the M.T Kasalu Women of Honor Award, presented by LIZADEEL in the Democratic Republic of Congo.

COUNCILWOMAN PAULA MCCRANEY

DR. RITA G. GREER EMERGENT LEADER AWARD

Known for her quick wit and energetic personality, Councilwoman Paula McCraney lives her life with the understanding that to whom much is given, much is required. On November 6, 2018, she was elected as the first African American to serve as the District 7 representative on the Metro Council. She proudly represents over 28,000 residents from Hubbard Lane to Goose Creek and suburban cities within the main thoroughfares of Brownsboro Road. Westport Road, and Shelbyville Road. In January 2023, her peers elected her as the President Pro-tem and Majority Caucus Chair. She also serves on the budget committee, committee on committees, and co-chair of the Women's Caucus. In addition to her Council committee duties, she is an appointed member of the Equity in Contracting and Procurement task force, the Juneteenth Jubilee Commission, and served on the Inspector General Search Committee and the Police Chief Advisory Search Committee.

The Councilwoman has co-sponsored several critical pieces of legislation, including the ban on 'No-Knock' Search Warrants and the creation of the Commission for Persons with Disabilities. She is the architect of the landmark Civilian Review and Accountability Board ordinance and co-chaired a 33member task force to write the legislation and lobby for its approval. The legislation was passed on a 25-1 vote by the Metro Council and signed into law on December 2, 2020. Councilwoman McCraney sponsored the Animal Abuse Ordinance, which legislates the "link" between animal abuse and interpersonal or domestic violence. This ordinance was passed unanimously by the Metro Council on October 28, 2021. Among



her many honors, in 2022, Councilwoman McCraney was recognized by the Kentucky Gazette as a "Notable Woman in Kentucky Politics and Government." She is also a Kentucky Colonel and Business First Newspaper 40 Under 40 award recipient. She received the Landmarks of Excellence Award from the Public Relations Society of America and was featured as "Influential" in the publication "Who's Who – African American Profiles."

Ms. McCraney is a Spalding University Doctor of Education and Leadership program doctoral student. She earned a master's degree in management and leadership from Webster University and a Bachelor of Science in business administration from Oklahoma State University. Additionally, she is a graduate of Leadership Kentucky, Leadership Louisville, Focus Louisville, and the Bingham Fellows and Courier-Journal Newspaper Forum Fellows Programs.

Paula is the owner of two businesses. As President/CEO of P Mc & Associates, she serves as a performance management consultant, and as owner/operator of the Traveling Boutique, she sells clothing, jewelry, hats, and men's accessories and creates women's hats and fascinators.

Utilizing her creative right brain, Paula was commissioned by the Kentucky Opera to write five songs relating to social justice. The songs debuted to a sold-out crowd at the Kentucky Opera on June 10, 2023. She has also written and directed five stage plays entitled Getting Past Your Past; He Restoreth My Soul; Nothing New Under the 'Son'; Those Triumphant Women; and The Woman at the Well: The Untold Story.

women experience enrichment and life changing moments through this conference.



On a personal note, she was born and raised in Louisville, KY, by an extremely hard working single mother, Stella Bright, for many years. As a result of addiction, her father, Michael T. White, was inconsistent until age 10, when he entered recovery at the Talbot House. She grew up surrounded by the principles of recovery and attended AA meetings with her father, who passed 20 years sober, in August of 2016 from cancer. His struggle with addiction and journey of recovery has allowed her to have an empathic perspective that is required



when treating people with addiction. I'd like to use this perspective in guiding families in shaping a new beginning.

Dr. Walker, along with her sisters, also founded a nonprofit, the Seeds of New Leaf, in honor of their father. The mission is to help people break barriers to recovery. The staple program is the Rolling Recovery program - this is a 24/7 treatment on demand van. If you call the number, someone will help you navigate your recovery needs, pick you up, take you to the most appropriate level of care and pay for your rent if a sober living home is needed.

She is also the founder of Green Door Real Estate Investments, which is a company that provides residential/commercial property space for those in our community.

Lastly, she and her daughter started Skylar's Slime Shop this year, which consists of quarterly pop up slime lab events. Skylar is 7 and a fierce young entrepreneur.
